To order an iP1 pistol, please complete this form in its entirety and mail it with a copy of a Federal Firearms License (“FFL”), to Armatix USA, 6 Beach Road Suite 111, Belvedere Tiburon, CA 94920. When we receive your completed order form and FFL, we will email you an invoice for payment, which will include shipping charges and, depending on your state’s requirements, may include sales tax. Payment in full (by credit/debit card, money order or cashier’s check) is required before the iP1 pistol(s) will be shipped. If paying by credit/debit card, we will send you the invoice listing the final amount to be charged before shipping your iP1 pistol(s) or charging your card. If paying by money order or cashier’s check, please mail it, along with a copy of the invoice to armatix USA, Inc.
